# FOREWORD

---

Dear Friends of The Damien Center,

To reflect back on 2014, I must first start with thanking you for your continued support of The Damien Center. Without your generosity, we could not continue to advance the fight against the spread of HIV/AIDS in Central Indiana and help our clients live healthier and longer lives by reducing their HIV viral load to an undetectable level.

The battle to end HIV continues, and today, with the advancement of HIV medicine, our clients have both extended life expectancies and greater personal needs. The Damien Center's one-stop-shop approach provides a holistic range of services, including testing, Linkage to Care, medical support, Care Coordination, mental health and substance abuse counseling, legal services, housing services, and nutritional support.

Furthermore, the HIV/AIDS healthcare landscape has recently undergone substantial changes, including the implementation of the Affordable Care Act, the evolution of public health strategies in response to HIV, redirection of HIV funds, the medicalization of HIV prevention, and the advancement of the National HIV/AIDS Strategy. With these changes, it is vital that The Damien Center increase its focus on accountability and on continuing to deliver high impact programs in order to remain relevant.

In 2014, the agency took steps to expand and enhance its programmatic and organizational capacity to compete in this new healthcare environment. With a generous \$1.3 million capacity-building grant from The Health Foundation of Greater Indianapolis, The Damien Center can continue to provide the highest level of services to meet the needs of our clients by:

#### **Office Expansion**

- Adding three medical clinic examination rooms and one medical lab area
- Adding a mental health and substance abuse counseling wing, which houses five offices
- Adding three offices for Compliance and Quality Assurance staff
- Adding four offices for Development staff (one office is also shared with the bookkeeper)

#### **New Employees**

- Hiring a third full-time mental health and substance abuse counselor
- Hiring an additional full-time HIV/STI tester for early intervention services
- Hiring a director of development and communications to focus on raising new, unrestricted income through fundraising efforts, as well as managing volunteers to offset internal costs

#### **Website/Marketing**

- Partnering with SmallBox to develop a new and expanded website for the agency, with a major focus on developing a strategic marketing and communications plan

The capacity-building grant has allowed The Damien Center to expand and enhance the services that we provide to our clients and continue to be a leader in the fight against HIV. I, along with the staff of The Damien Center, know that without our partners, funders, donors and advocates, we could not provide the comprehensive and integrated approach to care that is greatly needed by our clients. All of you make the work we do and the excellent care our clients receive possible. THANK YOU!

# PREVENT STOPPING HIV IN ITS TRACKS

More than 1.2 million people are living with HIV in the United States, and 14% (one in seven) don't know they're infected. There is no cure for HIV, but **TESTING** and **PREVENTION** can help stop the spread of the virus. We believe in empowering choices through education, and we offer resources and support to reduce the spread of HIV.

## HIV TESTING DEMOGRAPHICS

### HIV & STI TESTING

Our free and confidential HIV and STI testing by state-certified testing staff is available both on site at the Joseph F. Miller Testing Center and at various satellite locations. Testing is always free and always confidential, and our friendly testing team members make testing as easy as possible. We test for HIV, pregnancy, and STIs, including syphilis, gonorrhea, chlamydia, and trichomoniasis.

### PROJECT CORE



Project CORE is an innovative outreach effort that reduces transmission of HIV among racial and ethnic minorities recently released from incarceration.

### PREVENTION OUTREACH

Our Prevention Team works in a variety of ways to create a community that is more informed about how HIV affects us all. Whether providing prevention messages to clients accessing services with community partners, speaking with students in classrooms, or providing HIV 101 training for your workplace or staff, we will tailor prevention messages to fit your group's needs.

### COMPREHENSIVE RISK COUNSELING (CRCS)

Through CRCS, anyone infected with or affected by HIV and AIDS can utilize risk-reduction support in a sensitive and culturally competent environment.

# CONNECT

## LINKING CLIENTS WITH CARE

The Damien Center offers HIV+ patients a comprehensive approach to wellness. **LINKAGE TO CARE** connects clients with the support they need and helps them overcome barriers – such as transportation or insurance – while **CARE COORDINATION** provides HIV resources and support.

### LINKAGE TO CARE

A new program in 2012, Linkage to Care provides people living with HIV in the greater Indianapolis area an extra level of individualized, one-on-one support so they can successfully access and stay in medical care and supportive services. People who are newly diagnosed have 24-hour access to support via phone and text to ensure successful entrance into care. The program also targets HIV+ individuals who have been out of care for a year or more and provides the support they need to identify and eliminate individual barriers to care.

### CARE COORDINATION

Care Coordination is comprehensive, specialized, free case management that connects individuals living with HIV to the resources they need to live long, fulfilling lives. Our Care Coordinators help individuals access medical care, housing support, and other services and programs we offer. Bilingual staff and Kids Club help meet the varied needs of all patients and their families.





# CARE FOR ENSURING WHOLE-BODY WELLNESS

For those living with HIV, working toward comprehensive wellness requires a holistic approach. **MEDICAL SUPPORT** and **MENTAL HEALTH SERVICES** help patients reduce the amount of HIV and increase the amount of healthy cells in the body while also emphasizing mental health, individualized support, and overall wellness.

## DYK?

The Damien Center served more than 3,200 individuals in 2014 through programs and services for both HIV+ and HIV- populations.

### MEDICAL CLINIC

Established in 2012, our on-site medical clinic provides medical care at The Damien Center. Patients can meet with a nurse practitioner and manage their medical needs. The presence of the clinic also allows The Damien Center to more accurately track the HIV viral load of our clients, a key indicator of health in individuals living with HIV.

### MEDICAL CASE MANAGEMENT

New in 2012 and continuing to grow, Medical Case Management at The Damien Center helps patients navigate their medical needs, from setting up appointments with our on-site clinic to adhering to HIV medications. Our Medical Case Managers are a direct support line for patients' medical needs.

### MENTAL HEALTH SERVICES

Overall wellness includes managing mental health, in addition to physical health. We offer Mental Health Counseling, Substance Abuse Counseling, and Comprehensive Risk Counseling services to supplement and support other programs for our clients. Our team of dedicated, trained, and qualified counselors have a wealth of experience and training and support our clients as they seek overall wellness. The Damien Center also offers psychiatric care to our clients who are enrolled in counseling services.

## PROVIDING KEY SUPPORTIVE SERVICES

**SUPPORTIVE SERVICES** allow our clients to access safe, affordable housing and other programs that promote stability and enhance their quality of life. From nutritional support to emergency financial assistance, our clients are empowered to live healthy, fulfilling lives.

### HOUSING ASSISTANCE

Safe, stable, and affordable housing offers the best opportunity for our clients to access drug therapies, treatments, and other services that will enhance their quality of life. When both HIV+ and high-risk HIV- people are housed, they can better manage other needs and become healthy and self-sufficient.

### FOOD PANTRY

Meeting basic nutritional needs is critical for those living with HIV, who are already facing an often debilitating health condition and must maintain strong basic health to fight their HIV infection. By accessing our food pantry, they can keep their bodies strong.

### DIRECT EMERGENCY FINANCIAL ASSISTANCE (DEFA)

Direct Emergency Financial Assistance (DEFA) helps clients with short-term rent, incidentals, utilities, transportation, medication copays, food, or other one-time emergencies.

### BUILDING A FUTURE

Building A Future is a series of classes designed to teach essential life skills and includes a wide range of topics from goal setting and legal rights to housing resources and nutrition on a budget. Our Building A Future classes are free and are available to all Damien Center clients.

### LEGAL SERVICES

Legal services allow our clients to address needs ranging from preparing documents to accessing eligible benefits. Legal staff also address HIV-related discrimination or breach of confidentiality and help clients prepare for custody options of legal dependents.

# FUNDRAISING & EVENTS

Everything we do at The Damien Center is provided free of charge to the community, from HIV and STI testing to mental health counseling. With support from donors and volunteers through **FUNDRAISING & EVENTS**, we continue to offer these critical services to those who need them most.

## DINING OUT FOR LIFE

On April 24, 2014, 48 local restaurants donated 25, 50, or 100% of their day's sales to The Damien Center. Here's how it worked: there were no codes, no special menus—diners only needed to eat! This year's event raised \$77,500 for The Damien Center and reached 10,000 local diners. In 2014, Red Lion Grog House returned for the third year as a Champion Restaurant, donating 100% of April 24 food and beverage sales to The Damien Center. Red Lion was also joined by newcomer Champion Restaurant Labor District Cafe!

## GRANDE MASQUERADE

The 27th Annual Grande Masquerade: The Wicked Event, The Damien Center's largest fundraiser of the year, was held on Saturday, October 18, 2014. The event raised essential funds that allow The Damien Center to continue providing HIV preventive, medical, and supportive services completely free of charge.



